## Royal Agricultural Show - 22nd July,1972 Use of Air-strip for Pleasure Flights

The Town Council had under consideration at their meeting on 29th August, 1972 letter dated 9th August, 1972 from AIRGO theorganisation who operated the pleasure flights from Dernoch Aerodrome on the eccasion of the Annual Show on 22nd July, 1972.
