#### Gentlemen

With reference to the Ordinary use licence number P583 which has been issued by the Civil Aviation Authority in respect of Dornoch Aerodrome for the period ending 19 July 1973, I am directed by the Commissioners of Customs and Excise to draw your attention to Section 24(3) of the Customs and Excise Act, 1952 (reproduced in full below) which requires that the person in control of a licensed aerodrome shall keep a record in an approved form of all arrivals and departures of aircraft.

I am accordingly to request you to keep a record, in such manner as to show the particulars listed below, of all aircraft which arrive or depart at any hour of the day or night.

#### Arrivals

Date and time of arrival.

From whence, and date and time of departure therefrom.

Registration letters of aircraft.

Name of aircraft commander.

Whether carrying:-

- a. passengers
- b. cargo

#### Departures

Date and time of departure.

Destination.

Registration letters of aircraft.

Name of aircraft commander.

Whether carrying:-

- a. passengers
- b. cargo

The Customs officer responsible for inspection of your records will shortly visit the aerodrome, and will give you any necessary advice.

# Customs and Excise Act, 1952. Section 24(3)

The person in control of an aerodrome licensed under any enactment relating to air navigation and, if so required by the Commissioners, the person in control of any other aerodrome shall -

- a. keep a record in such form and manner as the Commissioners may approve of all aircraft arriving at or departing from the aerodrome;
- b. keep that record available and produce it on demand to any officer, together with all other document kept on the aerodrome which relate to the movement of aircraft; and
- c. permit any officer to make copies of and take extracts from any such record or document.

### Dornoch Aerodrome

I refer to your letter of 4th August, 1972 requesting the Town Council, as licensee of the above air-strip, to keep a record of all comings and goings of aircraft at the strip.

The only scheduled flights at present in operation at Dornoch are the following, as operated by Loganair Ltd. whose registered office is situated at 100, Wellington Street, Glasgow, G2 6DJ

Wick		0925		Inverness	depart		1530
Dornoch	depart	10.00	1715	Dornoch	arrive	0830	1545
Inverness	arrive	10.15	1730	Wick	arrive	0905	1620

These flights only operate on Wednesdays and only land if there are any passengers to embark or disembark at Dornoch.

It is noted that you require a record of all aircraft landing or leaving Dornoch. In this connection I have to advise you that very few private aircraft use the air-strip and sometimes come in unheralded, accordingly it is impossible to obtain the information you require.

The reason for the latter is that the Town Council have a very limited staff of workmen and only the requisite number are on duty when the scheduled flights take place. There are no employees on constant duty at the Air-strip.
