tenants. His plans had to undergo some modifications. A proposed village at Pittentrail never got beyond the drawing-board; both there and at Lairg it was necessary to allow the tenants to build where they wished. But the general picture is of detailed changes on a local basis; Young's remarks on the decision not to clear Muie throw some light on this. Although Strathfleet was surveyed during this period, as were the Strath of Kildonan, Strathbrora and Strathnaver, this was not the prelude to a major reorganisation. Instead, something approaching the Dornoch and Lairg system of small arable farms took shape in the lower parts of the parish. The shock to custom was probably severe: the physical dislocation of the parish community was not.

DORNOCH

In Dornoch, a traditional grain-growing parish, the pattern had been largely set by Falconer's leases of 1809 and 1810. There, in addition to leasing arable farms for nineteen years, Falconer had given a number of improving leases to settlers on the muits of Dornoch and Evelix from 1807 onwards; rents were nominal for seven years, on condition that two-thirds of the land was improved in that time. There were ten of these settlers in 1807, but no more than thirteen by 1809. Young's operations at Whitsunday 1811 largely completed Falconer's pattern of nineteen-year tacks, opportunity being taken to rationalise some boundaries; there were no general rent increases.

There were, nevertheless, some distinctive features in the Dornoch situation. One was the taking-over of Skelbo by Earl Gower, which led to a sharp increase in the parish rental in 1812. Another was the formation of a sheep-farm in Strathcarnoch for Captain Kenneth

Mackay of Torboll at Whitsunday 1813. The most striking, however, was the development of muir settlement. This was done partly to meet immediate local needs, as at Achavandra, where ten existing tenants gave way in 1812 to Earl Gower's farm and a group of twenty settlers appeared on muir ground, and at Balvraid, which Young divided into three farms and a muir settlement. In these two instances it is possible to see something of what happened. Seven of the Achavandra tenants reappeared as muir settlers, and ten out of fifteen at Balvraid, while two others may have gone to the Achavandra settlement.

In the older settlements on Dornoch and Evelix muirs new settlers were in evidence from 1812 onwards in numbers too great to be explained by local needs. There were thirty-two settlers in all on Achavandra, Dornoch and Evelix muirs in 1812, and forty-one in the following year; in the same period the Balvraid settlers increased from twenty-three to twenty-seven. A filling-out of a pattern begun in 1807 is to be detected. But this should not be exaggerated. The overall total of settlers only increased from ten in 1807 to sixty-five in 1815. The settlements were surviving at the end of the period, but it is impossible to rate them more highly than that, and they were as yet contributing little in the way of rent, beyond a profusion of probably stringy and tough hens.1 Young's operations had produced a temporary upsurge of settlement, some of it in all probability from outside the parish, but it would be unwise to see a highly developed programme in this.2 The fact that at the close of his factory the tenants had still not received written titles indicates how provisional the process had so far been.

Stafford's express instructions are to bring the Country into a progressive state of improvement which can only be done by a different arrangement of the Farms their wish at same time is to provide for every one of the old tenants in some shape or other, and to let them have a reasonable quantity of improveable ground and if possible a little old land at a very low rent." Young hoped to give nineteen-year leases, or ninety-nine year feus in Pittentrail village. Sellar wrote to Earl Gower on 17 Apr. 1811 that Young had reverted to his 1809 survey, 'namely to put it into compact Small Turnp and Grass farms of from 30 to 50 acres (each having a proportion of pasture) for the accommodation of industrious husbandmen."

That Young had some principles in mind is shown by a letter he wrote to Loch on *11 Oct. 1815: 'With respect to the lands loted out for the people, the quantity depends on the age, circumstances and number of Children which each person has, as well as the Local situation for you know one good acre on the Coast Side is worth three in the Straths of Kildonan and Fleet. Some of the Skelbo and Proncy most estellers have 20 acres others only 5, they get what they ask 7 years rent free under an obligation to improve the whole within that period, then at a rent to be fixed by men mutually chosen, or if they agree now at 2s. 6d. per acre. On the whole no fixed quantity of Land can be named it varys from one to 20 acres.'
