The factor of the Earl of Sutherland finding that notwithstanding the ample time allowed for the Warned Tenants to remove themselves from each parish home not yet gone from the professions they were warned to leave at that Sunday 1817 and being Desirous to afford every decaradin to them in his power does hereby interegate that he will yet ofer to send out the officers of the law untill Thursday the sixth day of May Current which is positive by the latest day to which he can or will defer his duty does intermate that upon the morning of the sixth day of May current the warrants will be delivered to the officers of the law and every person whom they may find it necessary to eject shall be made to pay not only ths expenses of his or her ejection but also the rents and Interest Due for there Disobedience of the Law and of the orders of the Marquis and Marquess of Stafford so often and so tenicous by no trifled.

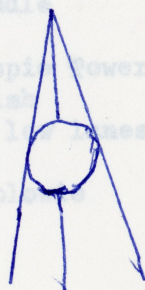
