RULES OF PROCEDURE AND STANDING ORDERS FOR CONFERENCE.

- 1. No business other than that shown on the Agenda may be taken at the Conference, unless Urgency be voted. An urgency motion must be clearly explained, and if the question is controversial, two-thirds of the meeting must agree to its discussion.
 - 2. No motion or amendment may be discussed or put to the Meeting unless it is seconded.
 - 3. Not more than one amendment or resolution may be discussed at one time.
- 4. A motion or amendment may be withdrawn by the mover and the seconder, with the unanimous consent of the Meeting.
- 5. Speakers opening and closing discussion will be limited to three minutes, exclusive of reading the resolution or amendment. Other speakers to one minute each. All Speakers must direct their speeches strictly to the motion or amendment under discussion, or to a question of order. Where the discussion is becoming irrelevant the Chairman may call the speaker to order. No member may address the Meeting more than once on the same question (unless asked by the Chairman to explain a statement or answer a question); the mover of a Resolution may, however, speak in reply at the end of a discussion.
- 6. A question may be asked from the body of the hall, but all questions must be strictly confined to a request for information and must not be a statement or argument.
- 7. Any member may rise to a point of order, any statement made to be strictly confined to the point concerned.
- 8. Any member may move "That the question be now put" and if this is seconded and carried, the motion or amendment under discussion must be put to the Meeting, without further discussion beyond the right of reply granted to the mover of the resolution or amendment which is under discussion.
- 9. Any member may move the previous question, *i.e.*, that the meeting proceed to the next business. This must be put to the Meeting and if carried the motion under discussion will be dropped. The "previous question" cannot be moved upon an amendment.
- 10. The vote shall be taken by show of delegates' cards and the result declared by the Chairman. If a division be challenged, the tellers shall count the delegates.
 - 11. Visitors to the Meeting may be invited to speak by the Chairman.

RECOMMENDATIONS AND RESOLUTIONS FOR DISCUSSION.

- 1. In order to facilitate business during war-time the Central Council has had to make some slight alteration in method of working. These are now brought forward for ratification:—
 - (a) Appointment of Vice-Chairmen (at present these are co-opted to Committees).
 - (b) Statutory Meeting of Council changed from November to April.
 - (c) Co-option of Conveners of Committees to Executive and Finance Committee, if they are not elected members.

3. FROM THE NATIONAL CONFERENCE COMMITTEE.

In re-arranging the paragraphs in the Handbook, the National Conference Committee agreed that in a few cases a slight alteration in words would make the meaning clearer. They therefore make the following recommendations (Suggested alterations in italics):—

Par. 13 on revised draft or Page 4 of Handbook.

Present wording "Federations should be organised in every County . . . " etc.

Recommend.—" A Federation should be organised in each County."

Par. 18 on revised draft or Page 5 of Handbook.

Present wording "The employment of organising secretaries if desired by the Institutes . . . "

Recommend.—" The employment of organisers or organising secretaries if desired by the majority of the Institutes in the counties concerned,

Par. 24 on revised draft or Page 5 of Handbook.

Present wording "elected for three years by the County Federations in the following proportion to the number of Institutes in each Federation."

Recommend.—" elected for three years by the County Federations in proportion to the number of Institutes in each Federation."

Par. 30 on revised draft or Page 6 of Handbook.

Present wording "The Statutory meeting of the Central Council shall be held in November and County Federation Committees shall send to the Secretary of the Central Council not later than 1st October a note of any business for the Agenda."

Recommend.—Omit first phrase to "November" and alter sentence to read: "Notes of any business for the Statutory meeting shall be sent to the Secretary of the Central Council not later than six weeks before the date of the meeting."

Par. 31 on revised draft or Page 6 of Handbook.

Composition of Executive and Finance Committee.

Recommended addition.—" The Executive and Finance Committee shall meet at least twice yearly, one of these meetings to be held at the time of the Statutory meeting of the Central Council."

Par. 34 on revised draft or Page 6 of Handbook.

Present wording "The Chairman and Hon. Treasurer shall be ex-officio members . . ."

Recommend.—"The Chairman, Vice-Chairmen, and Hon. Treasurer."

Par. 35 on revised draft or Page 6 of Handbook.

Present wording "Proxies on Executive and Sub-Committees . . . "

Recommend.—" Proxies on Executive and other Committees."

Par. 39 on revised draft or Page 6 of Handbook.

Present wording—" All changes of Constitution and Rules shall be decided by the Central Council. Any proposal for a change in the Constitution or Rules shall be made through a Federation. Notice of any such proposal shall be given to the Central Council at least six months before the meeting of the Council at which it will be considered, and the Council shall circulate it to the County Federations at least four months before such meeting, in order to enable members of the Central Council to obtain instructions. All such changes shall be brought forward for ratification by the Institutes at the next National Conference."

Recommended rewording of paragraph.—" Between National Conference meetings necessary minor changes in Constitution and Rules shall be decided by the Central Council. The recommendation for any such change shall be made to the Central Council by a Federation at least six months before the Council meeting at which it will be considered. The Central Council shall circulate it to the County Federations at least four months before the Council Meeting in order to enable Council members to obtain the views of their Federations.

"All such changes shall be brought forward for ratification by the Institutes at the next National Conference."

- (b) Need for representation on all important Women's Organisations in Scotland by someone directly in touch with both Federations and Central Council.
- (c) Need for someone able to leave Office and visit Federations and groups of Institutes and Areas.
- (d) The impossibility of adequately combining office control and organising in one person, under post-war conditions and probable expansion.
- (e) To co-ordinate and initiate work of national aspect and importance, someone is required whose whole time can be given to this side of the movement, unhampered by routine of office work.

Formation.—" To consist of one member per Area, all willing to meet regularly once a month—not necessarily in Edinburgh (it is suggested the Committee should meet in North, South, East and West and Centre in rotation). Chairman of Standing Sub-Committees be ex-officio members with powers to vote. For special purposes other members, not necessarily Central Councillors, may be co-opted.

- "No paid officials to be present at any meetings unless by request. Any notes taken at the meetings to be kept by the Convener and to be confidential.
 - "Meetings to be called by Convener.
- "Monthly statements and accounts from Central Council Office and Publications Office to be presented for discussion.
- "All Central Council and Publications appointments, other than typists, to be considered by this Committee before being presented to the Executive and Finance Committee.
- "No decisions to be taken by the Committee; it should be merely an advisory body, unless specific powers are remitted to it by Central Council.
 - "The Chairman of Central Council should ex-officio be the Convener."

Reasons for such a Committee being brought into being:—

- (a) To have a Committee whose finger is on the pulse of the Movement, its business workings and its repercussions in the Institutes.
- (b) To have a Committee who can at any time if necessity arose help the Chairman in any re-organisation of office matters, with the necessary knowledge in their hands. At present as the Advisory Committee is constructed, the members have only a very vague knowledge of the working of the office.

(c) To act as Liaison between the office and the Institutes—to bring into being a livelier and more informed interest into the business side of the Movement.
