He only sent the applications forward when he received them; the adjudication lay with the headquarter's of the Society and not with him.

## COUNTY COLLECTIONS.

It was reported that the result of "Our Flag Day" held on 2nd December last and subsequent days had not been received from headquarters yet. The Organising Secretary had written to Dr MacLachlan on the 12th inst., stating that "our treasurers are now busy getting the statements completed, and I am sure that they will lose no time in letting you know exactly how much money has been collected in your county." Dr MacLachlan said he would publish the lists in the local papers as soon as they were received. On the last Flag Day they had they collected a total of £249 8s 5d, and Dr MacLachlan said he would not be surprised if the result of "Our Day" would exceed that sum.

This hospital is worked entirely on behalf of disabled soldiers requiring treatment for stiff joints, restoring old injuries, scars, etc. The treatment would in all probability be a long one. Soldiers from this district for treatment in these cases will be sent to Oldmill, Aberdeen. The appeal was for a sum of not less than £3000, and Dr MacLachlan was sure Sutherland would respond well to it. He had written on his own well to it. He had written on his own responsibility to Mr Smith to say that col-lections for the Red Cross and other purposes had been made recently, and at present everyone was scraping together for the War Loan. He suggested that no appeal should be made till the month of April, as it seemed to him to be more suitable then. This was approved of.
