

RE-FLOORING OF DORNOCH SOCIAL CLUB

Further to our telephone conversation of Thursday 2nd June, I am writing to confirm the following;

- (1) We have obtained quotations for the work to be carried out; the lowest cost being £3800.00 + VAT, of which we as a Committee are prepared to carry out £500 worth, free of charge.
- (2) We are registered for VAT
- (3) The old floor is pine and softwood, whereas the new floor is to be Canadian maple hardwood. (see attached specification).
- (4) The floor has been declared unfit for heavy use i.e dances and discos. These form a large part of our revenue, and as we receive no outside funding, hires are our only source of direct income. We therefore feel that the reflooring must be completed before the autumn, or we risk losing these regular hires.
- (5) We would be willing to borrow money against later payment of grant.

- (6) We are arranging for additional fund raising events to assist with the project.

We would appreciate your advice on the possibility of obtaining a Capital Grant for the floor replacement, and particularly as to the timing of the release of any monies available for the project.
