On behalf of the New Dormoch Social Club, I write to ask about the possibility of financial assistance towards an essential but as yet unachieved part of the project.

As I expect you are aware, the old Dornoch Social Club has just undergone a considerable improvement with grants from the H.I.D.B. and H.R.C. and Scottish Education Department totalling £45,000 (forty five thousand pounds). To add to this figure the Dornoch Community raised a further £7,000 (seven thousand pounds) with numerous fund raising events over the last five years. With the effect of inflation and the uncertainty of continuing grant aid, the improvements had to be carried out within a very tight financial and time schedule.

Despite a lot of voluntary work with things like decorating and furnishings the main hall floor is virtually in its original state. While basically sound, the boards are very worn in places with the added problems of warping and unevenness. This unfortunately precludes the use of the hall for a number of facilities including indoor bowls and dancing (not the Disco type!).

Having only just opened the doors, the funds of the Association are expectedly depleted and we are only just starting to build up our finances again towards this next goal. Our Architect, Macdonald Associates, informs us that to level und resurface the floor in the main hall area will cost an estimated £3,000. (three thousand pounds) and it is to this end that we ask your consideration for financial assistance.

We could not expect to achieve this ourselves within three years but it would be a great boost if it could be completed before then, and it would allow fund raising to go towards various other smaller it ems that are ungently needed.

COMPLETION OF MAIN HALL AND COFFEE LOUNGE.

Further to our discussion I write to confirm that in order to complete the main hall and coffee lounge floors to an acceptable standard we require to raise a further £3,000.00 to pay for the work.

This is based on the use of a 6 mm thick oak strip glued and pinned to a chipboard floor which would be levelled using sprockets over the existing flooring. Some repairs are also required to the existing sub-floor and therefore the cost breakdown per square metre would be:-

A.	Repairs to existing timber floor and sanding same	€ 2.00
В.	Supplying and fixing chipboard sub- floor on levelling battens	3.00
C.	Supplying and fixing 6 mm t.&g. oak flooring	10.00
	Total:	£15.00

Based on these figures and knowing that the total floor area of the coffee lounge and main hall is 180 square metres then the total cost will be £2,700.00. Extra to this work there are the adjustments necessary to all doors opening from these spaces with the new floors and to all skirtings and therefore the provisional sum of £300.00 should be included for this.

We therefore arrive at the total cost of £3,000.00 for the installation of a new floor which would make the space much more attractive and easy to use.

I trust the foregoing clarifies the situation at present and look forward to hearing that the funding is available in order that we can proceed with these works.
