Dear Mr Wild,

We are writing you in response to your letter published in The Northern Times of 21st January.

With regard to the main issue, namely the helding of commercial sales in the Social Club, we are impressed by the working relationship you appear to have established with the Dornoch Business and Trades Association. We trust that the "give and take" attitude evinced will accrue to the benefit of both entities and of the community at large.

The point about which you are anxious to receive expressions of public opinion concerns the holding of sales on Sundays. Firstly, may we thank you for the considerate approach that you have adopted, and for your appreciation of the fact that in these matters "money is not everything".

Secondly, may we state unequivocally that should such sales go ahead, we shall be desply disappointed. We sincerely hope that your Committee will stand firm against the suggestion.

We would effer the following reasons in support of our view that Sunday sales should not be held in the Social Club.

1. We accept that the Sabbath observance which we advocate is no longer practised by a majority of the people of Dornoch. We also recognise that in our complex modern society, the area of activities covered by "works of necessity and mercy", permissible on the Lord's Day, is wider and mere difficult to define than in the past. But having said that, it remains true that a significant minerity of Dornoch people would be greatly offended by the holding of such unnecessary sales on Sundays in a local community centre. Individual traders who open on Sundays are concerned for personal profit, and are guided in the matter by their own conscience. A community association, by its very nature, seeks to serve the whole community, and must bear in mind the convictions of all the people it represents. While it needs to pay its way, its aim is not to make any profits other than those that will benefit the community.

2. Since all pasties accept that the total number of sales has to be limited, the wishes of local traders and the need for income for the Community Association can be adequately met without recourse to additional sales on Sundays.

3. While we are fully aware that Christian meral standards are rejected by many of our fellow-countrymen, we submit that they are still binding on human conscience and conduct. Short-term material gain cannot compensate for long-term spiritual and meral loss. Other arguments against Sunday trading have undoubted weight but it is on this ground that we base our strongest appeal to you. God's meral law has permanent relevance, and we should not assume to ourselves the right to set it aside, nor make it more difficult for others to respect it.

Again we would thank you for your courtesy in requesting these views from us, and express our hope that they will prove acceptable to you.

The social club has to be entirely self-supporting and, as such, is considerably helped by the revenue from commercial sales. The entertainments committee, which is the fund-raising branch of the social club, has been very successful, but as there are many other clubs and charities trying to raise money, there is a limit to what one organisation can raise and what you can expect people to give.

If sales were completely stopped in the social club, the traders would just go elsewhere in the locality, and in fact we have already seen this when sales have been held in local hotels.

We consider it better that the users of the social club benefit rather than other commercial organisations. Despite this, we do not want to bite the hand that feeds us.

The local traders have been very good to us over the years and we therefore have an agreement with Dornoch Business and Trades Association to hold up to 12 sales a year, with a maximum frequency of two a month. We also agreed to

Sir — I refer to your article charge a realistic hire fee, and this about itinerant traders and Sunday now means a one-day sale costs in now means a one-day sale costs in the region of £100 for advertising and rental, on top of which they have travelling expenses, accommodation and wages.

The result of this is that the number of traders wanting to come is, to a large extent, self-regulating, and last year we saw a considerable drop to only four

They do obviously represent some extra competition for a few days a year, but the goods for sale are often of inferior quality to that available locally, so people can pay their money and make their choice.

Regarding Sunday trading, that was a new venture for the social club. It is now a well-established practice in Scotland, as it is, in fact, in Dornoch.

To the social club, and hence to the community, it meant a way of doubling the income from a sale with little extra effort.

However, money is not everything and if any one person or organisation has strong feelings either for or against, I would be pleased to include those views in the discussion on the subject at our next management meeting - Peter Wild, secretary, Dornoch Com-munity Association.

And Take Your Choice

Sir - I read with growing impatience the reports and correspondence on the subject of itinerant traders.

I am impatient with retailers who, by continually complaining, must make the buying public suspect that the one-day sales must

offer better value.

The itinerant trader has been with us for a century or more; their pack-horses have been super-ceded by lorries and they will not go away. But they are no bigger threat than the multiples in Inverness or the mail-order catalogues. retailers must compete with them in our own ways and in each type of trade there must be an answer if we look for it. So retailers stop bleating and start competing.

However my real impatience is with the buying public increasingly dashing over the Kessock Bridge to stock up for the month or buying the new season's goodies at the multiples. There's no answer to it.

It is too tempting, even for fellowtraders I suggest, but as Mr Taylor of Bouar Bridge wrote last week, we are surely going to finish up with ghost towns.

Retailers need popular lines to subsidise slow selling odd lines, small or big sizes etc. The 'multi's'' only criteria is profit margin and if they can't afford to stock odd lines then the private trader certainly can't either. Have you heard anyone remark "I was you heard anyone remark "I was in Inverness on Saturday, but I couldn't find half the things I wanted". You may have also remarked about local shopping "You cant get any in the village now."

I suggest that there's a connection. Think about it before you find your local shop no longer stocks the odd things you couldu't find in Inverness, or has even closed down in disgust. — Gordon J Mackie, Golspie Footwear, Station Road, Golspie.
