

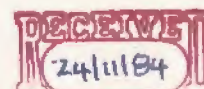

Building Scotland Acts 1959 & 1970
Dornoch Social Club.

Further to our telephone conversation regarding the use of the above club as a residential base for children for limited periods, I can not find any reason to prevent its use for this purpose as a few Highland Regional Council and other community buildings are used for similar purposes.

The requirements for fire resistance and escape routes would be the same for A3 & C2 which would be the categories to be considered, if a change of use was applied for and the Kitchen and Toilet facilities would possibly differ only slightly.

However as the main function of the building is as a social club, I would assume that no change of use will be applied for and therefore the Building Scotland Acts could not be considered in this particular case.

Emergency Lighting, alarm, escape and fire fighting provisions.

Inspection carried out 7 December 1984 by Peter Wild and Stuart Gardiner to compare the existing provisions with the requirements of the Building Warrant Drawing Ref. 206/80 issued by Sutherland District Council 21 November 1980.

MAIN DOOR:

No illuminated EXIT sign over door. 2 gallon water filled extinguisher provided.

SCOUT ROOM:

No illuminated EXIT sign over door. Fire extinguisher is a 4.5 kg dp. Should be a 9 kg dp.

MAIN HALL TO PORCH:

No 9 kg dp extinguisher.

MAIN HALL TO FIRE ESCAPE:

Access poor due to protrusion of stage.

Fire extinguisher is a 4.5 kg dp. Should be a 9 kg dp.

GAMES ROOM:

Doors to corridor and to main hall should be free from fittings. Both have mortice locks fitted.

Emergency light over door to hall is not marked with EXIT.

KITCHEN:

Remove sliding bolt from main exit door.

Fire extinguisher is a 4.5 kg dp. Should be a 9 kg dp.

COFFEE ROOM ENTRANCE:

No Yale night latch fitted but two sliding bolts are fitted. No 9kg dp fire extinguisher.

RECOMMENDATION:-

1. Fit night latch to Coffee room entrance door and remove sliding bolts.
2. Remove sliding bolt from Kitchen door.
3. Remove mortice locks from doors from Games Room to corridor and to Main Hall.
4. Permit better access to Fire Escape behind stage.
5. Invite the Area Fire Prevention Officer, John Faulds of Thurso, to inspect the premises to determine what action is required regarding emergency EXIT Signs and Fire Extinguishers.

COMMENT:-

Although this inspection has been carried out with a view to letting the hall in the summer for residential use it is my strong recommendation that the Committee authorise expenditure for items 1,2 & 3 immediately as I am of the opinion that the fittings which presently exist on these doors are potentially hazardous and could, in the event of a fire occurring in the building, trap occupants within the premises.

Every hall should be regularly valued to ensure that the sum insured is the full current replacement cost of the building etc.. Claims are rated down if the full current value is not insured. It will be appreciated that it should be done annually. It could well be that when this new assessment is made the actual cost to the hall would not be increased if we can get cover at greatly reduced terms by group insurance.

However, armed with these quotes, perhaps your own insurance company will be eager to keep your business and will offer you more attractive terms.

The actual date and venue for the meeting will be announced nearer the time but it was agreed that all hall committees would wish 2 months to assess their position.
