Minutes of meeting held on Monday, 25 February 1985 at Lairg Community Centre.

1. Present

2. Apologies

3. Mr Bill Ashplant, Chairman of East Sutherland Council of Social Service was in the chair and welcomed everyone to the conference. At the last meeting of East Sutherland Village Halls in November 1983, the possibility of a joint insurance policy was raised. Since then ESCSS asked several insurance companies for quotes, and as £1 million worth of buildings is required for such a policy, the conference was opened up to the whole of Sutherland.

Village Halls representatives gave their present insurance coverage as follows:

Total of those present = £820,000. Lochinver would definitely be interested in joining, therefore possibly only one more hall would be required to make a joint insurance policy feasible. Also, some of the above halls may decide to increase their cover.

On the question of the best way of valuing a hall, it was generally felt that an architect was best qualified.

Before proceeding, the Chairman asked if everyone wished to pursue the idea of a joint insurance scheme. Those present voted unanimously in favour.

The Chairman asked for proposals for a particular company. Mrs Currie (Dornoch) proposed Commercial Union, whose quotes would cut costs by approximately one third. The Chairman suggested inviting an expert from Commercial Union to meet with Village Hall representatives.

As regards the administration of such a scheme, the Chairman explained that the Council of Social Service was not a continuing agent, but was rather a catalyst body for initiating ideas. In other areas, a federation of village halls could administer the scheme and Mr Ashplant suggested a Federation of Village Halls would be of great benefit to Sutherland.

Mr Falconer, Lairg, as an insurance representative, said it is now difficult to get a bulk insurance policy, therefore it would be very worthwhile taking advantage of the offer.

Mr Ashplant proposed asking one representative from Commercial Union, seconded by Mrs Currie.

Mrs Fyfe counter-proposed asking two representatives to compare policies, seconded by Mr Macleod, Rosehall.

A majority voted in favour of asking one representative from Commercial Union.

Mrs Burnett will invite the representative on behalf of ESCSS for a meeting at Lairg Community Centre on Monday, 25 March at 8.00 pm.

The Chairman asked for further questions on insurance. Mr Mackenzie, Rogart asked if the Prudential could be approached for a quote, as a number of halls have insurance with Prudential at present. Mrs Burnett agreed to do this.

Mr Falconer said that each hall would require to update on their position as concerns insurance each year and this could prove to be an administrative problem. It was generally felt that the insurance company should do this. Mrs Burnett suggested payment be made by bankers order.

As there were no further points on insurance, the chairman thanked everyone for their co-operation, and asked for other matters to be raised.

4. Repairs

Mr Docherty, Ardgay, asked where he could get financial assistance for major roof repairs. The following were suggested:

Sutherland District Council: Responsible for maintenance and repairs, but very little money for giving assistance.

Highland Regional Council: Will not normally assist with repairs, unless for extension to a building.

HIDB: Social Grant per Mr John Watt, HIDB, Inverness.

Beatrice Oil Trust Fund (through Sutherland District Council): Only for groups with charitable status.

Community Councils

Mr Keniston, Lairg suggested it was worthwhile speaking to your MP as regards help for village halls.

Mr Ashplant pointed out that repairs and construction now require 15% VAT payment. It is possible to register for VAT and thus reclaim tax paid, but this would also require dance tickets, etc. to have charges inclusive of VAT and a certain amount of Book-keeping.

5. Water Rates

The Chairman expressed concern that, although village halls have 100% relief of rates, there is no relief of water rates. As the amount of water used by halls is generally considerably less than that used by a house, he felt this issue might be raised by a Federation, if formed. Most hall representatives felt that as they had 100% rate relief, they would prefer not to draw attention to this by raising the issue of water rates.

The Chairman suggested that Mrs Burnett write on behalf of ESCSS to seek the official response on this matter.

6. Electricity

The Hydro Board charges village halls electricity at the <u>commercial</u> rate. Mrs Currie pointed out that Dornoch hall has applied for evening and weekend tarriff which offers the cheaper rate at peak times for halls.

7. Bulk Purchasing

Mrs Fyfe handed out a list of cleaning materials and their costs with 10% reduction for bulk buying. The quotes from A & J Beveridge are considerably cheaper, but require only one delivery point. Other companies may be able to offer comparable savings.

8. Charges

The subject of charges for schools as against charges for halls was raised. Mrs Fyfe explained that youth groups, unemployed and educational groups all have use of schools free of charge. In setting up self-help groups, Community Education try to encourage use of village halls where possible, although often schools have the equipment necessary for classes.

Helmsdale Community Centre normally charge £15 for let of the hall, but for the Keep Fit class, for example, they charge 50p per person, no matter how many attend.

Mr Ashplant reiterated the idea that a Federation would be of benefit to all village halls, not just for insurance, but for the opportunity to exchange ideas at an annual meeting.

He thanked everyone for attending and for their contribution to the meeting.


I refer to your recent letter and to the subsequent inspection of the Dornoch Community Centre, and would comment as follows:-

- 1. There is no objection to the premises being used for residential accommodation on the clear understanding that the upper floor is used for storage purposes only.
- Your limit of 30 persons is within the safe occupational capacity of the premises. However, it would be preferable to limit the sleeping areas to the main hall and the games room.
- 3. The person in charge of the party should be made aware of the fire safety equipment and its operation in the building, and it should be ensured that the fire alarm and emergency lighting systems are tested immediately prior to the arrival of the party.
- 4. The matters specified in Mr Gardners report to the committee should be acted upon.


