
I am writing on behalf of Dornoch Social Club management committee to thank you very much for your generous cheque for £295 which we will be putting towards our amenities fund.

VILLAGE HALL INSURANCE. DORNOCH

I refer to the proposed block policy for insurance, and apologise for the lengthy delay since this matter was first discussed.

The question of building values was raised at the meeting in Lairg and I was asked to provide an estimate of the rebuilding cost for each hall.

Having now seen your building, I am of the opinion that in the event of total loss by fire, the approximate cost of reinstatement at present prices, including architects and surveyors fees, would not be less than £240,000

This opinion is offered without obligation, in good faith, and to the best of my knowledge and belief, but I am not a professional valuer and neither I nor the Company can accept any responsibility for its correctness.


Based on the above figure, the premium for the building cover, along with glass and liability cover, will be in the region of £255-00

The premium for the contents cover will obviously depend on your own valuation of the contents of the hall but as the rate is only £1.00 per thousand, this will not add greatly to the above figure.

I await your advices on whether you wish to participate in the scheme, and it would also be helpful if you could advise the expiry date of your present insurance.
