

I regret I have not answered your letter of July 3rd before but this is explained by the fact that I have been constantly in communication with the Sheriff on the subject of the Catering, and I understand he is dealing with this matter at the Committee Meeting which I ^{have been} unable to attend. 

This Leaflet Cancels Leaflet No. 10.—It is merely explanatory of the provisions of the law with regard to the liability to, and the method of payment of, Entertainments Duty which are contained in the Finance (New Duties) Act, 1916, sections 1 and 2, the Finance Act, 1924, section 6, and the Entertainments Duty Regulations, 1921. No expression or omission in this leaflet must be interpreted as in any way modifying the statutory requirements.

ENTERTAINMENTS DUTY.

I.—LIABILITY TO THE DUTY.

1. NATURE OF THE DUTY.—The Entertainments Duty is a Duty levied on payments exceeding sixpence for admission of persons to any entertainment as spectators or members of an audience. Thus it is chargeable on payments for admission to see or hear an entertainment, *e.g.*, an exhibition of cinematograph films or a football match or a concert, but not on payments to take part in an entertainment, *e.g.*, a dance or a whist drive.

2. RATES OF DUTY.—From and including 2nd June, 1924, the Rates of Duty have been as follows:—

3. PERSONS ADMITTED TO AN ENTERTAINMENT WITHOUT PAYMENT.—The Duty is not leviable in the case of persons admitted to an entertainment without payment (either direct or indirect) on a free or complimentary ticket clearly marked as such. But if, though the admission is nominally free, the person admitted pays indirectly for the right of admission by having, for example, to purchase a programme or to contribute to a collection as a condition of admission, the cost of the programme or the requisite contribution to the collection must be regarded as a payment for admission, and if it exceeds 6d. the Duty must be paid thereon.

4. DUTY PAYABLE ON PAYMENT FOR ADMISSION OF EACH PERSON SEPARATELY.—Where a combined payment is made for the admission of two or more persons, the Duty is payable, not on the combined payment, but on the payment in respect of each person to be admitted. Typical examples are given below:—

Boxes.—The Duty payable is not on the price charged for the Box but is the sum total of the Duty on the maximum number of admissions at the proportionate price for each. Thus, if the price charged for the Box is 2*l.*s. and the maximum number of persons entitled to be admitted is four, the Duty is 4*s.*, *i.e.*, the sum total of the Duty on four payments of 5*s.* 3*d.* each (*see* paragraph 17).

Vehicles.—The Duty on the payment for admission of a Vehicle must be calculated similarly, if the Vehicle is to be used wherefrom to view an entertainment.

Books of Tickets, including Sheets of Tickets, Family Tickets, etc.—The Duty payable is not on the price charged for the Book, etc., but is the sum total of the Duty on all admissions covered by it at the proportionate price for each. Thus, if the Book costs 10*s.* and covers 10 admissions, the Duty is 1*s.* 8*d.*, *i.e.*, the sum total of the Duty on ten payments of 1*s.* each (*see* paragraph 17).

5. BOOKING FEES AND EARLY DOOR PAYMENTS.—

When a seat is booked at the office of a theatre or other place of entertainment and a booking fee is charged, the Duty is leviable on the total price paid for admission including the fee, and that total price must be shown on the ticket. This applies also to extra payments for early doors. Fees charged by outside agents, however, for the convenience of booking, are not regarded as payments for admission.

6. TRANSFERS.—When a person transfers from one seat or place to another at the same entertainment, as for example from the Gallery to the Pit at a Theatre, or from the Ground to the Grand Stand at a Football Match, the additional Duty payable is, not the rate of Duty on the transfer payment, but the difference, if any, between the rate of Duty on the original payment for admission and the rate of Duty on the aggregate of the original and transfer payments. Thus, on a transfer from a 6*d.* seat (Duty nil) to a 1*s.* 6*d.* seat (Duty 4*d.*) the additional Duty is 4*d.*, but no additional Duty would be payable on a transfer from a 1*s.* 6*d.* seat (Duty 4*d.*) to a 2*s.* seat (Duty 4*d.*). When, however, a person is admitted without

payment on a complimentary ticket and subsequently transferred to another seat for payment, the Duty is leviable on the amount of that payment. Thus the Duty on a payment of 1*s.* for a transfer from a 6*d.* seat (complimentary) to a 1*s.* 6*d.* seat is the Duty on 1*s.*, *viz.*, 2*d.*

Payment for admission to a Side Show is not a transfer.

7. SUBSCRIPTIONS TO CLUBS, ASSOCIATIONS AND SOCIETIES LIABLE TO DUTY.—

Subscriptions to Clubs, etc., are liable to the Duty if they confer the right of admission to entertainments. But where the subscription represents payment for other rights, privileges or purposes as well as for the right of admission to entertainments, the Duty is chargeable only on such part of the subscription as is determined by the Board of Customs and Excise to represent the right of admission to entertainments. The application of the Duty to Club, etc., subscriptions is fully explained in Leaflet No. 7.

8. COMBINED ENTERTAINMENTS.—Similarly, where an entertainment is in part dutiable, *e.g.*, a concert, and in part non-dutiable, *e.g.*, a dance or whist drive, the Duty is payable on such part of the payment for admission to the combined entertainment as is determined by the Board of Customs and Excise to represent the right of admission to the dutiable part of the entertainment. If it is claimed in any case that the Duty should only be levied on part of the payment for admission, an application should be made to the Board for assessment as long as possible beforehand, giving full particulars of the case.

II.—METHOD OF PAYMENT OF THE DUTY.

9. METHOD OF PAYMENT.—The Duty is payable by means of Stamped Tickets of Admission unless the Board of Customs and Excise have issued their written Authority for other arrangements. Failure to use Stamped Tickets where such Authority has not been issued renders the Proprietor of an entertainment liable to penalties.

10. RELIEF FROM USE OF STAMPED TICKETS.—Stamped Tickets are not required at Places of Regular Entertainment where the Board of Customs and Excise have authorised a standing arrangement for the payment of the Duty on the basis of Returns furnished to them of payments for admission. At all such Places an Official Form of Authority is exhibited at the public entrances. The Board authorise similar arrangements for occasional entertainments in cases where good reasons are shown for dispensing with stamped tickets.

11. STAMPED TICKETS OF ADMISSION may be either Government tickets (that is, tickets supplied by the Customs and Excise Department, which are imprinted or impressed with a stamp denoting the Duty) or Proprietors' own tickets to which are affixed adhesive Excise Stamps denoting the Duty. Tickets must be stamped at the time of sale.

12. GOVERNMENT TICKETS.—The price of admission and the rate of Duty are printed separately on Government Tickets thus: "Admission 1s. Tax 2d."

In addition to the above, **GOVERNMENT TRANSFER TICKETS** are supplied for use in the case of Transfers. They are marked "Transfer—Additional Tax," and imprinted with a stamp. The following stamp denominations of these Tickets are obtainable, namely: ¼d., 1d., 1½d., and 2d.

13. DESCRIPTION OF GOVERNMENT TICKETS.—Government Tickets measure 2½ inches by 1½ inches. Tickets at each of the prices of admission shown above up to and including 2s. 6d. and Transfer Tickets at 1d. and 2d. are supplied in Rolls of 1,000 Tickets each and in Pads of 50 Tickets each.

Tickets at prices exceeding 2s. 6d. and Transfer Tickets at ¼d. and 1½d. are supplied in Pads only. The tickets in each Roll or Pad are numbered consecutively. Roll Tickets are printed in six colours (white, brown, green, blue, pink and yellow), at each price of admission, and if a particular colour or two or three different colours are required, the fact should be stated. All Pad Tickets are in one colour only—namely, white.

14. PURCHASE OF GOVERNMENT TICKETS.—Government Tickets may be purchased in quantities of not less than a complete Roll (1,000 Tickets) or pad (50 Tickets). They are supplied at the face value of the stamp printed on them, no charge being made for the material of the Tickets. They can be purchased on Personal application at the Customs and Excise Office at the places named in the Appendix. Where there is no such Office within convenient distance, orders from places in England and Wales should be sent by post to:—

The Collector of Customs and Excise,

Custom House, London, E.C.3.

Orders from places in Scotland should be sent by post to:—
The Collector of Customs and Excise,
14, Waterloo Place,
Edinburgh.

A crossed remittance payable to the Collector of Customs and Excise, London or Edinburgh, as the case may be, for the total stamp value of the Tickets required must accompany each order. When cheques are sent sufficient time must be allowed for clearance through the Bank, but cheques guaranteed by the issuing Bank will be accepted as cash. Coin, Treasury Notes or open remittances should not be sent. For the convenience of purchasers an Official Form of Order is provided, copies of which may be obtained from any Customs and Excise Office, and if this Form is used a Money Order, free of commission, may be obtained at any Money Order Office in Great Britain for the amount of remittance.

Tickets should be ordered according to the price of admission printed on them and not according to their stamp value. Transfer Tickets should be ordered as "Transfers," at the particular stamp values required.

The Tickets will be despatched to the purchasers by Registered Post either on the day of the receipt of the order or on the next working day.

15. ADHESIVE EXCISE STAMPS for affixing to Proprietors' Tickets are printed at the following stamp values, namely: ¼d., 1d., 1½d., 2d., 3d., 4d., 6d., 9d., 1s., 1s. 6d., 2s., 3s., 4s., 5s., 8s., 10s. They are supplied in sheets of 120 at all values, and also in rolls of 480 at values of 2d., 3d., 4d., 6d., and 9d. They can be purchased in any quantity on Personal application at any Head or Branch Post Office and certain Sub-Offices, or at the Customs and Excise Office at the places named in the Appendix, or they may be ordered by post from the Collector of Customs and Excise, London or Edinburgh, in

the same way as Government Tickets. Adhesive Excise Stamps must not be issued by the Proprietor of an Entertainment otherwise than securely affixed to tickets of admission.

16. ALLOWANCE FOR UNSOLD STAMPED TICKETS OR UNUSED STAMPS.—The owner of any unsold Stamped Tickets (whether Government Tickets or Proprietors' Tickets to which Adhesive Stamps have been affixed) or unused stamps, may claim allowance in respect of those for which he has no immediate use. Applications for allowance may be made either *personally* to Collectors of Customs and Excise, or through certain Postmasters, or *by post* direct to the Accountant and Comptroller-General, Entertainments Duty, Custom House, London, E.C.3. Adhesive Stamps affixed to Proprietors' Tickets must not be removed therefrom or defaced in any manner if allowance is to be claimed. No allowance can be made for Stamped Tickets which have been sold by the Proprietor of an entertainment, but have not been used by the purchasers to gain admission to the entertainment, or for stamps or tickets which were not purchased within the period of two years next preceding the application.

17. PRICE OF ADMISSION TO BE MARKED ON TICKETS.—Proprietors' own tickets of admission must be clearly printed or marked with the price, and a statement whether such price is inclusive or exclusive of the Duty. Where the price covers the admission of more than one person, *e.g.*, in the case of Boxes and Vehicles, the ticket must also state the maximum number of persons entitled to be admitted (*see* paragraph 4). In the case of Books of Tickets, including Sheets of Tickets, Family Tickets, etc., each ticket in the Book, etc., must be marked either with the price charged in respect of the ticket or the total price charged for the Book and the number of tickets in it (*see* paragraph 4).

18. ISSUE AND DEFACEMENT OF STAMPED TICKETS.—Stamped Tickets must be issued whole and undefaced by the Proprietor of the Entertainment to the purchasers. The persons to be admitted must present the Tickets in the same condition at the time of admission, and each Ticket must thereupon be torn into two portions across the Stamp by the person collecting it on behalf of the Proprietor, who must retain one portion and hand the other to the person admitted. The Proprietor and the person admitted must produce their respective portions of the Stamped Ticket on demand by any Officer. The Proprietor must keep his portions of tickets used each day separate from those used on previous days, and must not destroy them before mid-day on the day following the entertainment to which they relate.

19. DEFACEMENT OF STAMPS ON SEASON TICKETS AND BOOKS OF TICKETS.—When adhesive Excise stamps are affixed to Season Tickets the ticket must not be torn into two portions across the stamp at the time of admission, but the stamp must be defaced by writing across it in ink the date of issue of the ticket. The same procedure is to be followed when stamps are affixed to the cover of Books of Tickets and not to the separate tickets included in the Book.

Leaflet No. 5 explains the details of the reliefs in respect of charity entertainments.

Leaflet No. 7 deals with the Duty on Subscriptions to Clubs and Societies.

Leaflet No. 11 sets out the conditions of the various statutory reliefs from the Duty.
