Emergency Sewer and Roadwork

Closure of Station Road, Dornoch - 11th to 15th March, 1974

It is necessary to close Station Road, Dornoch for the period commencing 11th to 15th March, 1974 in order to carry out emergency sewer and roadwork. The area affected will be that from the New Curiosity Shop (Old Station Building) for a length of approximately 70 yards to a point at the junction of Stafford Road/ Station Road.

During the period of closure it is suggested that your buses on their outward journey to Embo, be along Station Road to the Industrial Site, thence throught the Site connecting up again with Station Road at the County Roads Depot. The journey into Dornoch from Embo being along the same route only in reverse.

It appears that this is the only way to meet the situation and I shall be glad to have your acceptance to this as the solution to the problem.

Emergency Sewer and Road Work

Closure of Station Road, Dornoch 11th to 15th March, 1974

I refer to our conversation today and confirm that from 11th to 15th March, 1974 will be the period required for the closure of Station Road, Dornoch in order to carry out emergency sewer works there.

The length of the road required to be closed will be that from the New Curiosity Shop (Old Station Building) for a length of approximately 70 yards to a point at the junction of Station Road/Stafford Road.

I have written today to the Highland Omnibus Company informing them of the proposed closure and suggesting that during this period their out of Dornoch to Embo be along Station Road to the Industrial Site and thence through the Site and joining up again with Station Road at your Department's Depot; the return journey into Dornoch being along the same route, only in reverse.

DEAR SIR,

I hereby grant you permission to open up part of the Public Road or Footpath at Station Road, Dornoch. for the purpose of Clearing Choked Drain subject to the following conditions:—

- (1) The work to be carried out carefully and expeditiously at your expense and to my satisfaction, and one-half of the roadway to be kept open for traffic.
- (2) In opening the track the metal or tar macadam shall be carefully laid on one side and replaced on top at completion, large stones shall also be kept apart and used as bottoming under the metal. In refilling track the material shall be replaced in layers not exceeding 6 inches in depth, firmly beaten together and watered if necessary, the top-coating being left not more than one inch above the adjoining surface. *see addition*
- (3) During the progress of the work sufficient precautions must be taken by you by fencing, watching, lighting or otherwise, where necessary, for the safety of the public and for the passage of traffic along the road.
- (4) The County Council shall be relieved by you of all claims, loss, damage, and expenses, for which they may be held liable or incur through your operations.
- (5) All pipes, sewers, drains, mains, cables, or other property laid by you under the road to remain at your own risk. No claim shall lie at your instance against the County Council for the repair or renewal of, or for any damage to such property.
- (6) When it is necessary to have a surface box on the roadway the shaft supporting this shall be built of stone or brick in cement mortar and shall rest on a solid foundation of ~~stone~~ concrete. The shaft shall be lintelled over the pipes, cables, etc., in such a way that no weight can be transmitted to these from any traffic passing over it. The surface box must be left level with the adjoining surface of the roadway.
- (7) The County Council shall undertake the final reinstatement of the road surface or footpath at the following rates, which shall be payable to them by you. You will, until permanent reinstatement is effected, maintain the surface of the track in safe order. Neglect to do so will result in the Council's undertaking temporary reinstatement at additional cost.
