## Dornoch Airstrip

The County Planning Officer has been investigating the future of the airstrip in Dornoch with Officials of the Board of Trade. The Board of Trade's advice at the moment is that the strip in its present form seems to be satisfactory for the known traffic conditions. Any proposal for licensing the strip would presumably be made to take advantage of scheduled services and the existence of a licensed strip at Dornoch, in itself, would not contribute very much to the operation of a scheduled service.

The Board of Trade point out that the authority which would apply for a licence, in this instance the Town Council, would have to satisfy themselves, after consultation with the local operator, who, in this case, is Loganaire, that the licence is necessary. If the Town Council so decide the requirements are laid down in the Board of Trade's letter to the Town Council dated 26th February, 1970. These are as follows:-

- 1. Fire-fighting Equipment It might be possible to get a vehicle cheaply through the Scottish Development Department, who are at present auctioning off vehicles and pumps.
- 2. Manpower for Fire-fighting This could be reduced from/

from 3 men to 2 men and equipment and men must be available for every aircraft movement. Other Authorities which operate small strips have made use of local volunteer fire units on an agreed turnout scale of pay.

- Threshold Markers This is a simple provision and is estimated to cost not more than £50.
- 4. A Windsock This is already in position.

In addition to these requirements it might be necessary to provide the following additional works:-

- (a) A telephone coin box This would be unlikely to cost more than £30 or so at the usual Post Office quarterly rental.
- (b) The construction of stockproof fencing for the parking area. - This would cost about £250.
- (c) The provision of an open-ended building for protecting aircraft. In 1969 this was estimated at £750.
- (d) Levelling and Rolling the site Estimated at about
- (e) Laying a metalled access road from the end of the existing tarmac. road to the airstrip This has not been estimated. It is thought unlikely that the cost would exceed £1,000.

The last two items might be carried out as an Army exercise and a request has been made to the Army Authorities for this.

Perhaps your Council could now consider the whole matter in the light of the information contained in this letter and let me have their views.

## Dornoch Airstrip

I refer to your Council's application for financial assistance under Section 8 of the Highlands and Islands Development (Scotland) Act 1965.

The Board have considered the application and I have pleasure in informing you that in connection with the proposed improvement of the airstrip at Dornoch it has been decided to offer Sutherland County Council a grant of £1,000 or one-third of the total approved cost whichever is the lesser sum.

The main Conditions upon which this Grant is offered are set out in the attached Appendix. If these are acceptable please let me have written confirmation to that effect by 9th November 1971. If no reply is received by that date the amount, terms and Conditions may be subject to review or withdrawal.

In the event of your Council's accepting financial assistance on the Conditions referred to, the Board will duly instruct their Solicitor to prepare a formal Undertaking regulating the Grant, as well as such other documents as may be necessary.

It is possible that in the future the Board may wish to publicise the assistance which has now been approved for this project and perhaps you would let me know if your Council would be agreeable to this if the occasion arose. You would, of course, be consulted beforehand and the terms of any publicity decided upon would be as agreed between your Council and the Board.

- 2. The grant will not be paid over until all the legal formalities have been completed and all the relevant detailed receipted vouchers in respect of materials and labour shall have been seen by the Board and the work inspected and a certificate in terms satisfactory to the Board shall have been submitted to them in regard to the cost of the several works in respect of which the grant is offered.
- 3. The Council shall fully insure against fire and other risks all property and buildings belonging to it or used by it at the said airstrip, as well as all plant and machinery, equipment, stock and other assets belonging to it or for which it may be responsible thereat, and the relative policy or policies as also the receipts for all premiums paid in respect thereof shall be exhibited to the Board.
- 4. The airstrip on which the grant is paid shall not be used for any other purpose or be sold or otherwise disposed of nor shall the use thereof be discontinued within a period of five years from the date of the last payment of grant otherwise the whole amount of the grant paid in respect thereof, or such portion of the same as the Board may at its sole discretion decide shall be immediately repayable to the Board.
- 5. The Board have approved this financial assistance on the firm understanding that they accept no liability for further work to ensure that the airstrip will qualify for any type of licence for charter and/or air ambulance flights.

## Bornoch Air-Strip

Dornoch Town Council, with the help of Sutherland County Council and the Highlands and Islands Development Board are carrying out certain requirements in order tomest the Board of Trade conditions for a 'J' Licence for Dornoch Air-Strip.

Would you be kind enough to inform me of any course that might be available. How many men would be involved, how long the course would take and the cost involved.

Further to our telephone conversation on 22 November 1971, herewith are details of our Training School, and courses for 1972.

The 'School' is situated at Standted Airport in Essex, and is staffed by Fire Officers of the Department of Trade and Industry (formerly the Board of Trade), and courses are held there for aerodrome firemen throughout Britain, including a course of one week's duration (five days) for aerodrome fire and rescue personnel, from the lower category aerodromes, that is aerodromes where only light aircraft are catered for, such as you anticipate at the Dornoch airstrip.

The old classification of aerodrome licences (you quoted a 'J' licence) no longer applies and now only two types of licences are issued Viz. "Public Use" or "Ordinary".

An aerodrome granted a public use licence must be kept open during the times when the aerodrome is notified as being available, and it must be available for the landing and take-off of aircraft to all persons on equal terms and conditions.

An aerodrome granted an ordinary licence is normally available only for use by the licensee. It may, be used by other persons only with the licensee's prior permission.

Further information on this subject must be sought from the Divisional Controller, Civil Aviation Office for Scotland, Broomhouse Drive, Edinburgh EH11 3XE.

Ideally, all men engaged in fire and rescue duties should attend the training school, but at least one member must attend so that he is able to take charge of the crew, and supervise the testing of equipment and training of any new members.

Courses suitable for your men are being held at Stansted on the following dates:-

31.1.72 to 4.2.72 and 1.5.72 to 5.5.72

and if you let me know as soon as possible, I will reserve a place or places on the courses you require, and send you the papers which need to be completed, before your men report to the School.

The cost of this course, which includes residential accommodation, is £30.00 and meals can be obtained at moderate rates in the School canteen. Protective clothing will be made available to the student, at the School, but he should take his personal toilet requisites.

## Dornoch Air Strip

I refer to your letter dated 26th October, 1971 addressed to Sutherland County Council regarding the conditions under which the Board were prepared to make a grant of up to £1,000 for the development of Dormoch Air-Strip to meet the requirements for a 'J' licence.

A copy of your letter was passed to me by Mr.J.B. Rodger, the County Clerk, whom I understand has informed you that we would be writing to you direct on the matter.

Your letter has been considered by the Town Council and they have, for their interest approved of the conditions, with one small provise - namely No.4.

The land on which the Air-Strip is situated is Common Land and as such there are certain reservations which have to be complied with under legislation covering such land. The Town Council are of the opinion that the reference contained in item 4 which reads "The airstrip on which the grant is paid shall not be used for any other purpose be sold or otherwise disposed of nor shall the use thereof be discontinued within a period of five years from the date of the last payment otherwise ......" is slightly restrictive.

whilst there is no likelihood of the discontinuation of the Airstrip for the period mentioned or any intention whatsoever for any other use or disposal thereof the Town Council do not feel that they can altogether restrict the use of Airstrip for such purposes as local residents have a hereditary right thereto. It is therefore suggested that a slight amendment might be made to the condition so as to safeguard this interest.

There is no suggestion whatsoever by the Town Council that there is any other difficulty to restrict the development of the Airstrip as proposed. They are in full agreement with the said conditions apart from this small point.

I took this matter up with Mr. Rodger and he suggested that perhaps condition 4 might be modified by adding a phrase to the effect that none of the conditions specified in it will apply as a result of statutory enactment. This might well suit the circumstances and I shall be glad to hear from you.

## Dornoch Air Strip

I am in receipt of your letter of 22nd current enclosing my Minute of Meeting of Representatives held on 1st October, with amendments thereto made by your Council. I should mention that the Minute has been approved in its entirety by the County Council for their interest.

I note that your Council wish to have included the provision of telephone coin box and metalled access road. It was my understanding that these items were not required and that, in particular, there was no necessity for a metalled access road to meet the requirements of 'J' Licence. It was my understanding that the meeting of representatives had agreed to omit the provision of metalled access road and indeed that it had been explained that the provision of a telephone would not be required. If a telephone coin box is, in fact, required there would seem to be no problem particularly as the cost is minimal. The cost of providing a metalled access road is, of course, considerable and, as stated, it was my understanding that since a metalled access road was not essential, a saving could be effected by its omission.

Since your Council take the view that the Minute referred to does not correctly specify the decisions taken at the meeting, I shall require to take further instructions.

The representatives unanimously agreed that the Convener be appointed Chairman.

#### DORNOCH AIR STRIP

The Depute County Clerk reported the terms of Minute of Meeting of representatives held on 12th October, 1970, and there was submitted a report dated 30th September, 1971, by the County Planning Officer and County Development Officer. This report is appeared as an annexation to this Minute. The Meeting also heard a report by the County Development Officer who explained the circumstances in which it would not be possible to look for military assistance for any work on the Air Strip under the OPMAC Scheme for some considerable time.

The meeting heard a report by Provost Clunie who explained the action taken by the Town Council since the last meeting and who stated that the Town Council were satisfied that they did not wish to pursue the licensing of the Air Strip under J. Licence conditions in the meantime. He stated that the Town Council were agreed that there should be carried out at the Air Strip the minimum work necessary to improve it but without regard to the needs of J Licence conditions. He observed that matters had been held up pending a decision on whether work would be done as an OPMAC Scheme but he felt that it would now be appropriate for the constituent Authorities to themselves carry out the basic work required, which should include threshold markers, and omit work necessary to satisfy J Licence conditions until justification for these arose.

Mr Prophet Smith stated that the costs specified in the report of the Planning Officer and Development Officer did not appear to be excessive in regard to the provision of J Licence facilities and he stated that it was/ was the Board's view that the Air Strip should be licensed to meet J Licence conditions. The Board considered that this is an essential Air Strip, that therefore it must be licensed and that accordingly the constituent Authorities should accept the attendant costs. The meeting also heard a report by Dr. Skewis who explained the possible use of the Air Strip in the event of its being licensed and pointed out that the Board were examining the possibility of introducing an air service from Caithness to Inverness which would have an optional call at Dornoch if a licensed strip were available He believed that the cost of providing a licensed strip was not excessive and he believed that it would be a worthwhile investment. explained that a metalled access road and an open ended building were not essential pre-requisites for licensing and that these could be omitted. In reply to a query by Provost Clunie - who explained that the Town Council were worried by the need to provide specially trained men constantly available at the Air Strip and the attendant cost thereof - Dr Skewis explained that it would be ideal to use existing Council employees on a part-time basis who could be trained by Dalcross personnel, the training being fairly nominal.

Provost Clunie suggested that, having heard the Board Representatives, it appeared that the only items holding up the project were the levelling and rolling of the site and the County Surveyor explained that the work principally entailed keeping the grass cut on both runways as the foundations were good. Provost Clunie pointed out that a telephone box already existed at the Strip and that by a sharing of the work, the necessary provisions could be made to meet licensing conditions.

The Convener stated that, having heard the various parties represented at the meeting, he was satisfied that the constituent Authorities should proceed to carry out work necessary to meet J licensing conditions and that the Strip should be submitted to the Board of Trade for licensing as quickly as possible. Provost Clunie concurred.

The meeting accordingly unanimously agreed to recommend to the constituent Authorities that they proceed forthwith to carry out all work at the Strip necessary to meet J licensing conditions, having noted the agreement previously reached with the County Council, the Town Council and the Highlands and Islands Development Board that each meet one third of the cost, and that the County Surveyor prepare a report on the detailed costs involved in bringing the strip up to J licence standard, the necessary work being specified in the Appendix attached hereto with the exception of telephone coin box of open ended building and laying metalled access road, the County Surveyor's report to be submitted to the constituent Authorities as soon as possible. further agreed that the constituent Authorities should aim for the provision of a full licensed Strip by April 1972, that the Town Council should forthwith report to the Board of Trade the intentions of the constituent Authorities and, following completion of the necessary work, should apply to the Board of tion. W Keers Trade for the necessary J Licence. The Meeting noted that the report to be submitted by the County Surveyor would be in respect of both runways.

Gilmour (who although not a member of the Air Strip Committee, was invited to speak), agreed that Councillor Gilmour make whatever investigations and approaches he could with a view to keeping the work required at the Strip before the Military Authorities in case these Authorities found it possible to carry out the work as an OPMAC Scheme before the constituent Authorities were ready to proceed. The meeting further agreed that, in the likely event of the Military Authorities being unable to carry out the work as an OPMAC Scheme, the work should be carried out by the County Roads Department.

after hearing the Convener, agreed that this matter be considered further once a J Licence had been obtained and that, in addition, there would be considered at that stage the question of the charges to be levied at the Air Strip and the management thereof.

The meeting noted the view of Provost Clunie that the Air Strip Committee would require to continue in existence, once the Strip had been licensed and was operating, in order to deal with all matters pertaining thereto, until such time as the Re-organisation of Local Government had been completed.

The meeting instructed the County Clerk to make a formal approach to the Highlands and Islands Development Board in regard to their meeting the agreed share of the cost of the work.

#### APPENDIX

#### DORNOCH AIR STRIP

A quick summary of the proceedings to date are as follows:-

- 1. The Town Council, the County Council, and the Highlands and Islands Development Board have agreed, in the course of previous meetings to each bear 33% of the total costs of equipping and bringing Dornoch Airstrip up to the standard required for a 'J' Licence.
- These standards were laid down in a letter of 22nd March, 1971, a copy of which is enclosed for information.
- Further additional works have been suggested as being desirable to the functioning of the airstrip. Some of these items were suggested asbeing suitable subjects for an OPMAC exercise.

At the moment, there seems little prospect of the Military Authorities having personnel available for these tasks until late 1972. In view of this, I would suggest that the constituent bodies interested in this development should now proceed as early as possible, to have the necessary works completed and the airstrip licensed. The estimated costs are now as follows (updated from 1969).

These estimates show appreciable increases since first set out in 1969. It can be expected that further delays will result in greater increases.

The reservations concerning the worth of the expenditure above estimated in relation to the traffic potentially attracted by the licensing of the airstrip still obtain. The interested authorities may wish to consider restricting their intentions, as suggested in the letter of 22nd March, 1971, to a bare minimum without seeking a 'J' licence.
